Susie moved and Beth seconded that we pay our insurance and the tournament sanction fees, a total of \$295.00. Approval was unanimous.

Joe summarized our expenses and income since 2009. Both dues and clinics are slowly declining, though they're quite stable. The fundraising tournament for Doug D would have made us \$770.00, so there is potential in that. Block party attendance has declined somewhat, making it harder to collect dues. Beth raised the idea of ectronic payment of dues as a way to address this. National Mutual Benefit reported a total of \$45,669.00 for Doug D's fundraiser. Susie donated her wages for running this year's winter clinic and also donated the flyers she made.

Old Business: Susie and Doug S reported on their clinics. We may need to replace the portable nets at the Rec Center. Doug S. likes the format of two-hour sessions over three weeks instead of six.

New Board Member: Steve Reichert has agreed to be a new board member. Susie moved we add him to board, Joe seconded, and the decision was unanimous. Pat noted that Colleen Mischke is also willing to serve, though at this time the board is complete.

Tournament dates: This summer's tournament dates are set for June 29-30, with the alternate date July 13-14. The tournament is already on the USTA website. Kyle tabled further discussion of the tournament to the next meeting.
